

## **The “Casey James I Like Christmas Giveaway” Sweepstakes Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE AND LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

**Sweepstakes may only be entered in or from the 48 continental United States and the District of Columbia (excluding its territories and possessions) (collectively, the “Sweepstakes Territories”). Entries originating from any other jurisdiction are not eligible for entry. Void where prohibited or restricted by law, including, but not limited to, the states of Alaska and Hawaii. You are not authorized to participate in the Sweepstakes if you are not located within the Sweepstakes Territories.**

**1. Eligibility.** Participation open only to legal residents of the 48 continental United States and the District of Columbia (excluding its territories and possessions) who are eighteen (18) years of age or older as of December 2, 2014. Void outside of the 48 continental United States and the District of Columbia and where prohibited, including, but not limited to, the States of Alaska and Hawaii, and where taxed or restricted by law. Employees, officers & directors of Sony Music Nashville, a division of Sony Music Entertainment (“Sponsor”), and its parent company, subsidiaries, affiliates, partners, dealers, advertising and promotion agencies, manufacturers or distributors of Sweepstakes materials and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees, officers and directors are not eligible to enter.

**2. How to Enter.** The Sweepstakes will begin on December 2, 2014 at 11:00a.m. CT and will end on December 23, 2014 at 11:00 a.m. CT (“Sweepstakes Period”). To enter the Sweepstakes, visit <http://tweematic.com/caseyjames> during the Sweepstakes Period and complete the entry form with the required information, or connect via Twitter Connect, complete the entry form and share the <http://www.tweematic.com/caseyjames> URL with the pre-populated message and hash tag #ILikeChristmas.

Limit one (1) entry per person. If more than one (1) entry is received from the same person, only the first entry submitted by that person will qualify for entry in the sweepstakes; subsequent entries submitted by that person shall be disqualified. No automated entry devices and/or programs permitted. All entries become the sole and

exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Proof of submission will not be deemed to be proof of receipt by Sponsor.

**3. Winner Selection and Prizes.** One (1) Winner shall receive:

- One (1) CD;
- One (1) bag; and
- One (1) autographed guitar

Prizes are non-transferable. No substitutions or cash redemptions provided and Sponsor reserves the right to substitute the Prize in whole or in part for a prize of equal or greater value in the event that any component of the Prize is unavailable for any reason. Prizes may not be sold, bartered or transferred. Prizes do not include any additional expenses, including, but not limited to incidentals, meals, telephone charges, travel insurance, souvenirs, transportation, federal, state and local sales or other taxes and surcharges which are the responsibility of each winner. Approximate combined retail value of all prizes is Two Hundred Seventy Five Dollars (\$275.00) which may vary based on the location of the winner's primary home. The approximate retail value of the prizes represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prizes turns out to be less than the stated approximate retail value, the difference will not be awarded in cash. The winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release within three (3) calendar days of prize notification. If the winner rejects his/her prize or in the event of noncompliance with these Sweepstakes rules and requirements, such prize will be forfeited and an alternate winner may be selected. Upon any prize forfeiture, no compensation will be given.

**4. Random Drawing/Odds.** The winner will be selected in a random drawing on or

about December 23, 2014. The random drawing will take place at the executive offices of Sony Music Nashville, a division of Sony Music Entertainment, 1400 18th Avenue South, Nashville, TN 37212. The odds of winning depend on the number of eligible entries received. The potential winner will be notified by telephone or email and if a winner cannot be contacted within two (2) calendar days of first notification attempt, the prize will be forfeited and an alternative winner may be selected from all remaining eligible entries. By entering the Sweepstakes, entrants fully and unconditionally agree to be bound by these rules and the decisions of the judges, which will be final and binding in all matters relating to the Sweepstakes.

**5. Conditions.** All federal, state, provincial and local taxes are the sole responsibility of the winner. Participation in this Sweepstakes and acceptance of prize constitutes winner's permission for Sponsor to use his/her name, address (city and state), likeness, photograph, picture, portrait, voice, biographical information and/or any statements made by winner and winner's travel companion regarding the Sweepstakes or Sponsor for advertising and promotional purposes without notice or additional compensation, except where prohibited by law. By participating, entrants and winner agree to release and hold harmless Sponsor, and their respective advertising and promotion agencies and their respective parent companies, subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers and directors, from any and all liability, for loss, harm, damage, injury, cost or expense whatsoever including without limitation, property damage, personal injury and/or death which may occur in connection with, preparation for, travel to, or participation in Sweepstakes, or possession, acceptance and/or use or misuse of prize or participation in any Sweepstakes- related activity and for any claims based on publicity rights, defamation or invasion of privacy and merchandise delivery. **6. Additional Terms.** In the case of dispute as to the identity of any entrant, entry will be declared made by the authorized account holder of the email address submitted at

the time of entry. "Authorized Account Holder" is defined as the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization (e.g. business, educational, institution, etc.) responsible for assigning email addresses or the domain associated with the submitted email address. Any potential winner may be requested to provide Sponsor with proof that such winner is the authorized account holder of the email address associated with the winning entry. Any other attempted form of entry is prohibited; no automatic, programmed, robotic or similar means of entry are permitted. Sponsor, its affiliates, partners and promotion and advertising agencies are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, web site, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of entry information (regardless of cause) or failed, incomplete, garbled, jumbled or delayed computer transmissions which may limit one's ability to enter the Sweepstakes or claim a Sweepstakes prize, including any injury or damage to participant's or any other person's computer relating to or resulting from participating in this Sweepstakes or downloading any materials in this Sweepstakes.

Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Sweepstakes should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Sweepstakes. In such case, Sponsor will select the winner(s) from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds, in their sole discretion, to be tampering with the entry process or the operation of the Sweepstakes or web site. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in their sole discretion, they determine that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other entrants or Sponsor's representatives.

**7. Use of Data.** Sponsor may collect personal data about entrants in accordance with its privacy policy. By entering the Sweepstakes each entrant consents to the collection, use and distribution of his/her personal information (information that identifies an entrant as an individual, such as home telephone number, age and home address) by Sponsor for the purposes of implementing, administering and fulfilling the Sweepstakes. Sponsor will not sell or transmit this information to third parties unless the entrant has specifically consented to same, the Sponsor believe in good faith that it is required by law, to their affiliates (provided that such affiliates and their agents and advisors and their respective employees are restricted from using the information for any other purpose other than as described in these rules and regulations), or to their respective agents for data processing purposes, their respective professional advisors and promotional and marketing agencies (provided that such agents, professional advisors and promotional and marketing agencies are restricted from using the information for any purpose other than as described in these rules and regulations).

If any controversy or claim arising out of or relating to the Sweepstakes, the Official Rules, or the breach of any term hereof, cannot be otherwise resolved, it shall be submitted exclusively to the jurisdiction of the state courts of the State of Tennessee or the federal district courts of Nashville, Tennessee.
