

Logic Shazam Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT RESIDE WITHIN 150 MILES OF A CITY DRAWING CONCERT LOCATION.

The Logic Shazam Sweepstakes (“Sweepstakes”) begins at 11:59:59 AM Pacific Time (“PT”) on 4/4/18 and ends at 11:59:59 PM PT on 08/02/18 (the “Entry Period”). Sweepstakes consists of thirty-three (33) city drawings (“City Drawing”). Follow the drawing chart in these Official Rules for entry deadlines for a given City Drawing. The Sponsor’s agent’s computer server will be the time keeping device for the purposes of this Sweepstakes.

SPONSOR: Def Jam Recordings, a division of UMG Recordings, 1755 Broadway New York, NY 10019 (the “Sponsor”).

ELIGIBILITY: Sweepstakes is open to individuals who are legal residents of the 48 contiguous United States and the District of Columbia who reside within one hundred and fifty miles of a City Drawing concert location age 18 or older at time of entry (19 or older for AL & NE and 21 or older for MS). Void in Alaska, Hawaii and where prohibited by law. Employees, officers, directors, shareholders and representatives of Sponsor, Shazam Entertainment Limited (“Shazam”), Logic (“Artist”), and their respective parent companies, manager(s), labels, agents, crew members, affiliates, licensors, and anyone professionally associated with Artist, advertising and promotions agencies, retailers, distributors, and any other individual or company involved in the development or execution of the Sweepstakes (collectively, the “Released Parties”) and their immediate families (parents, siblings, children and their respective spouses) or individuals living in the same household of such employees (whether or not related) are not eligible to enter or win. No groups, clubs or organizations may participate in this Sweepstakes or reproduce or distribute any portion of these Official Rules to its members.

HOW TO ENTER: To enter, visit **NEW LINK** and using the Shazam App, Entrants can Shazam Logic’s “Everyday” to launch the sweepstakes form and follow all onscreen instructions to enter the Sweepstakes, including selecting which local City Drawing you wish to be entered (the “Entry”). If you do not have a Shazam app, you can download it for free at www.shazam.com/apps. Each entrant **must** select the City Drawing she/he wishes to be entered for a chance to win the tickets for that particular concert. Sponsor is not responsible for any travel and/or accommodations associated with attending a concert, if Entrant is determined a winner. By participating in the Sweepstakes, each Entrant is confirming that they have read and agree to comply with: (i) these official rules; (ii) Sponsor’s terms of use, located at <http://privacypolicy.umusic.com/terms/>; (iii) Shazam’s terms and conditions, located at <http://www.shazam.com/music/web/terms.html>; and (iv) all other Sweepstakes requirements. Upon submitting your Entry, you will qualify for the applicable City Drawing you elect to enter.

Limit: Regardless of method of entry, only one (1) Entry per person. Entries for a given City Drawing will only be considered for that particular City Drawing and will not qualify for another City Drawing. Duplicate entries will be disregarded. Multiple entrants are not permitted to use the same email address. All Entries, requests and/or materials submitted become the property of Sponsor and will not be returned or acknowledged.

By entering the Sweepstakes, each entrant agrees to grant to Sponsor a non-exclusive, irrevocable, royalty free, sub-licensable and transferable worldwide license, for any commercial and promotional purposes (without any consultation or additional permission, or compensation, credit or attribution) to use, re-use, reproduce, transmit, display, distribute, re-distribute, copy, store, modify, edit, adapt, translate, create derivative works based upon the Entry, in whole or in part, in all media, formats and channels now known or hereafter devised, for the duration of the rights in each area and space, and throughout the universe, in perpetuity and in all languages, formats and versions. By submitting an Entry, you agree that your submission is unsolicited and without restriction, and will not place Sponsor under any obligations other than those contained in these Official Rules, and that Sponsor is free to disclose the ideas contained in the Entry on a non-

confidential basis to anyone or otherwise use the ideas without any compensation to you. Released Parties are not responsible for any unauthorized third party use of any Entry. Furthermore, entrant acknowledges and agrees that Sponsor may obtain many Entry submissions under this Sweepstakes and that such Entries may be similar or identical in theme, idea, format or other respects to others submitted under this Sweepstakes and/or other Sweepstakes staged and/or sponsored by the Sponsor, and waive any and all claims entrant may have had, may have, and/or may have in the future, that any composition, Entry and/or other works accepted, reviewed and/or used by the Sponsor and/or Artist (or their respective designees) may be similar to his/her Entry. Entrant acknowledges and agrees that Released Parties does not have now, nor shall any of them have in the future, any duty or liability, direct or indirect, vicarious, contributory, or otherwise, with respect to the infringement or protection of any copyright in and to entrant's Entry. Entries are subject to all notices posted online including Sponsor's privacy policy.

ODDS: Odds of winning are determined by the number of eligible entries received for a given City Drawing.

PRIZE DETAILS: Thirty-three (33) First Prizes: One (1) First Prize awarded per City Drawing. Each First Prize winner will receive a pair of concert tickets to attend a Logic concert per the local market selected at time of Entry (ARV: \$50.00 per pair of tickets). **First Prize does not include transportation and accommodations which are each winner's sole responsibility.** All meals, ground transportation, taxes, gratuities, incidentals, upgrades, service charges or other expenses not specified herein are not included and are the First Prize winner's sole responsibility. First Prize winner and guest are responsible for obtaining proper documentation (i.e., valid photo ID), prior to concert. Certain restrictions may apply. The winner's guest must be 18 years of age or older (19 or older for AL & NE and 21 or older for MS) and will also be required to sign a release prior to concert. Total ARV for all prizes: \$1,200.00. Limit: One prize per person or household. If actual value of any prize is lower than the stated ARV when prize is procured and fulfilled, then the difference will not be awarded. No substitution of any prize offered, no transfer of any prize to a third party is permitted and prizes may not be redeemed for cash value, except by Sponsor, who reserves the right in its sole discretion to substitute any prize for a prize of comparable or greater value. All fees, federal, state, local or other expenses relating to the use, acceptance and possession of any prize are the sole responsibility of each winner. Taxes are the responsibility of each winner. Arrangements for the fulfillment of any prize will be made by Sponsor and/or its designated agent. Concert tickets are not for resale. Selection of concert seats are at the Sponsor's sole discretion. Each winner acknowledges that the concert is beyond the control of the Sponsor and is subject to being rescheduled, modified or cancelled. In the eventuality a winner cannot travel to attend the concert for any reason whatsoever, or if the concert is postponed, canceled or has occurred, no compensation or substitution will be provided and the Sponsor shall have no further obligation.

WINNER SELECTION: Each winner will be selected in a random drawing of all eligible entries received for a given drawing within two (2) business days from a particular drawing's deadline date. All random drawings will be conducted by the Sponsor or its agent of choice whose decisions are final and binding.

WINNER NOTIFICATION: An email prize notification will be sent to each potential winner ("winner") within forty eight (48) hours after a random drawing is conducted. Each winner must

also be able to receive calls from an unlisted/blocked number (or have access to) an Internet connection to receive emails from the Sponsor and/or its designated agent. The contact information provided at time of entry will be used to notify each winner. Each winner will be required to respond to the prize notification within five (5) hours of notification deployment in order to receive any required documents, including (if applicable) an Affidavit of Eligibility/Grant of Rights and Liability/Publicity Release ("Affidavit") which must be signed and returned to Sponsor or its designated agent within five (5) hours of notification deployment. If an Affidavit and/or any other required document is not returned within the specified time period, or if an Affidavit or prize notification is returned as undeliverable, or if the winner is otherwise found to be ineligible), or if a winner cannot accept or receive the prize for any reason, then the winner will automatically forfeit the prize and, at the Sponsor's sole discretion and time permitting, an alternate winner may be determined. A prize may also be forfeited if winner is not reachable at address or phone number provided at time of entry, or a forwarding address is not made available or any non-compliance with the Official Rules.

PUBLICITY: Except where prohibited by law, entry and acceptance of prize constitute permission for Sponsor and its agents to use each winner's name, prize won, story, hometown, likeness, photograph(s), and statements for purposes of advertising, promotion and publicity (including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission. RELEASE OF LIABILITY: By submitting your Entry, you agree to accept these Official Rules and agree to be bound by the decisions of the Sponsor, and on behalf of your respective heirs, executors, administrators, legal representatives, successors and assigns ("Releasing Parties"), release, defend and hold harmless the Released Parties. from any and all actions, causes of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, promises, variances, trespasses, lost profits, indirect or direct damages, consequential damages, incidental damages, punitive or exemplary damages, judgments, extent, executions, claims and demands whatsoever, in law, admiralty or equity, whether known or unknown, foreseen or unforeseen, against Released Parties which any one or more of the Releasing Parties ever had, now have or hereafter can, shall or may have which in any way arise out of or result from entrant's participation, acceptance and use or misuse of any Prize. Sponsor is not responsible for any typographical or other error in the printing of the offer,

administration of the Sweepstakes or in the announcement of prizes. In the event Sponsor is prevented from continuing with the Sweepstakes as contemplated herein by any event beyond its control, or otherwise, including but not limited to fire, flood, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state, or local government law, order, or regulation, or order of any court, or other cause, Sponsor shall have the right to modify, suspend, extend or terminate the Sweepstakes.

The Released Parties are not responsible for: (i) lost, late, misdirected, damaged, incomplete, garbled, invalid or illegible Entries; (ii) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of Entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive Entry information by Sponsor on account of technical problems or traffic congestion on the Internet or at any web site or any combination thereof; (iii) any injury or damage to entrant’s or any other person’s computer related to or resulting from participating in the Sweepstakes, or (iv) the failure of any third party to comply with the instructions and proper administration of this Sweepstakes.
